MEMBERSHIP CRITERIA

Full membership shall be open to any firm, corporation, or division of a corporation (provided, however, that no corporate group of parent, subsidiaries, and/or divisions shall be entitled to more than three full memberships) engaged, on a national basis within the United States, in manufacturing or importing for sale, distribution, or private labeling primarily new machinery, equipment, systems, software, or supplies (as defined by the Board of Directors) for printing, publishing, and converting technologies.

Associate membership is open to:

- (a) Dealers that sell other companies' branded products on a **local or regional basis** in the United States
- (b) Canadian and Mexican manufacturers without an office in the United States
- (c) Trade publications

Associate members are not eligible to serve on the NPES Board of Directors. Dealers and trade publications are not eligible to participate in the NPES Market Data Program. Trade publications are not eligible to receive PRIMIR studies.

DUES INVESTMENT

The NPES member dues investment is based on a company's sale of equipment, systems, software, or supplies for printing and publishing. First year's dues must accompany application. Thereafter, dues are paid annually on a calendar year basis.
